



Ahmedabad-Dholera Expressway work progressing at rapid pace; likely to open in 2024

Ahmedabad: The construction work on the expressway connecting Ahmedabad with the smart city of Dholera, is progressing rapidly. Once the Ahmedabad-Dholera Expressway is ready and operational, people will be able to commute between the two cities in 40 to 45 minutes.

The 109-kilometer expressway project is being constructed at a cost of Rs. 3600 crores. The expressway is divided into 4 packages, with Packages 1, 2, and 3 being expanded from 6-lane highways to 8 lanes, while Package 4 is designed as an 8-lane highway with the capacity to expand to 12 lanes.

Several YouTube vloggers have recently visited the expressway project site and created a detailed video about the project. We bring to you the observations made in several vlogs about the progress of this project.

Package 4 covers a 38-kilometer long section on a brownfield alignment. Construction work is progressing as per the requirement for a 12-lane highway, but currently, the road will have 8 lanes. Earthwork is underway, with a 2-lane road already operational. As you move toward Ahmedabad, the earthwork at the interchange is yet to commence, but structures for underpasses connecting to this expressway are fully erected.

Moving forward, the brownfield alignment ends at an interchange near the Administration Cum Business Center for Dholera (ABCD). Travelers from the ABCD building will be able to enter the expressway from the interchange located here. After this interchange, the greenfield alignment begins, where earthwork is in progress.

The 22.5-kilometer long Package 3 will facilitate the connection of the expressway to Dholera Airport. An elevated path is being created in the package, with pillars already constructed, and some pillars are even connected. Further along the road towards Ahmedabad, a vehicular underpass structure is ready to connect the existing airport road with the expressway. Work is currently ongoing to build the ramps near the underpass structure. Structures related to interchanges and underpasses are ready, while earthwork continues over this package.

As we move forward, Package 1 is substantially ready. The earthwork is complete, lanes are ready, and the remaining work involves plantation and lane marking. A canal passes through this area of the expressway, and the construction of the structure, including erected pillars, is completed with ongoing flooring work on the overpass.

Moving towards the entry point to Ahmedabad, construction work for the interchange is ongoing at the SP Ring Road within the city. Half of the circle at the interchange is undergoing earthwork, while the other half is nearly finished, requiring only road leveling work.

Overall, the work is progressing at a rapid pace, and the National Highways Authority of India (NHAI) is likely to open some sections of the expressway by April 2024, with the aim of full operation by December next year.

One noteworthy aspect of this expressway is the utilization of waste processed at the Amdavad Municipal Corporation-run Pirana Dump Yard in the embankment layer of the road on this expressway.



Dholera is slated to become a global manufacturing and trading hub, and plans for a semiconductor display fab manufacturing plant are underway.

The state is also exploring the possibility of Tesla establishing a presence in Gujarat. While the primary discussions are being led by the central government, Gujarat is ready to engage with Tesla to ensure its substantial role in the company’s plans.

Gujarat is committed to addressing climate change and has taken proactive steps in renewable energy. 1 Lakh Jobs To Be Created In Gujarat As Vedanta Plans To Manufacture Chips With Japanese Companies

On October 17, Indian multinational mining company headquartered in Mumbai, Vedanta Group said it is exploring collaborations with Japanese technology companies continuing its plan to set up a semiconductor fab in Gujarat.

Vedanta Explores Collaboration With Japanese Technology Giant
During the Vibrant Gujarat Global Summit roadshow in Japan, Vedanta’s semiconductor and display business Global Managing Director, Akarsh K Hebbar said that it is a USD 80-billion opportunity for companies willing to come and invest in the electronics manufacturing hub in Gujarat.

Further Hebbar outlined, “Vedanta’s ambitious plans to establish semiconductor and display fabs in Dholera SIR, Gujarat, and invited Japanese companies to partner with Vedanta in helping build the country’s first electronics manufacturing hub in the state.”

The hub has the potential to attract hundreds of SMEs and create more than one lakh jobs, he pointed out.

Adding, “There is a USD 80-billion opportunity for companies willing to come and invest in this electronics manufacturing hub, and Vedanta will be the anchor for Japanese companies interested in investing in India.”

Development of India’s Semiconductor and Glass Display Manufacturing Ecosystem
For the unawares, the Vedanta group firm, AvanStrate Inc is headquartered in Japan.

Notably, the company signed agreements with 30 Japanese technology companies to foster the development of India’s semiconductor and glass display manufacturing ecosystem, last year.

It is noteworthy here that Japan is also the second Quad partner after the United States to sign an agreement with India for the joint development of the semiconductor ecosystem and maintain the resilience of its global supply chain.

Besides this, Japan also stands among the top five countries to have a semiconductor ecosystem with around 100 semiconductor manufacturing plants.

Vedanta had earlier formed a joint venture with Taiwanese electronics manufacturing giant Foxconn as it announced plans to invest USD 19.5 billion in setting up a semiconductor wafer fabrication plant.

In addition to that both the firms have announced that they will invest in setting up electronic chip plants in India separately.
