#### AAI issues tenders for construction of 1st phase of Dholera airport in Guj



AAI on Thursday issued tenders for the construction of the first phase of an international airport at Dholera in Gujarat, entailing an investment of Rs 987 crore, according to an official statement.

The Airports Authority of India (AAI) on Thursday issued tenders for the construction of the first phase of an international airport at Dholera in Gujarat, entailing an investment of Rs 987 crore, according to an official statement.

The new facility is being set up in greenfield city under the Delhi-Mumbai Industrial Corridor (DMIC) project at Dholera.

Located in the north of the Dholera Special Investment Region (DSIR), the upcoming airport is expected to cater to not only DSIR and its hinterland but also to traffic overflow from the Ahmadabad international airport, it said.

"The AAI has release Rs 987 crore tender for Phase 1 of the Dholera International Airport, which will be aligned with a fire-station of Category-9, and will incorporate a 3,200-mts (metres) runway, which will be suitable for type 4E Aircraft," said the release.

The lack of international airport in Saurashtra and its vicinity will make Dholera international airport strategic and advantageous in many ways, it said.

The upcoming airport will be an advantage for the aerospace, defence and manufacturing industries who look forward to invest in the greenfield industrial smart city of Dholera, the statement added.

The Gujarat government has allocated 1,427 hectares of land for the project, and 75 hectares of government land has been allocated for commercial development.

Also, all the other relevant ancillary services will be developed by the government like power, water, flood control and roads, said the release.

# Gujarat govt clears Rs 6k-crore investments



GANDHINAGAR: In a positive beginning to 2021, the government has approved five big-ticket investment proposals by four companies, which will invest close to Rs 6,000 crore in diverse sectors. The companies will set up manufacturing facilities in Dholera and Halol.

The state industries and mines department has approved a proposal of ReNew Saksham Urja Private Limited (a 100% subsidiary of ReNew Power Private Limited), which has pledged an investment of over Rs 4,000 crore investment to set up a 2 to 4 GW solar module, cell manufacturing and lithium-ion battery production plant at Dholera. Government has approved 100-acre land allocation for the said project at Dholera Special Investment Region (DSIR).


#### Spate of approval

Baby diaper manufacturing brand Avgol's proposal for setting up a Rs 1,000 crore new technical textile plant at Halol has also been approved. The company has proposed to manufacture technical textile products and hygiene products at their Gujarat plant. Leading furniture manufacturing company Merino's proposal to establish a plant with an investment of Rs 630 crore at Halol has been approved. Merino has proposed setting up facilities for wood processing for particle board, pressing for particle board, pressing for pre-lam particles board, coating on pre-lam particle board, and cutting edging and drilling of furniture.

Another leading company Trafalgar's Rs 250 crore investment proposal has also got the nod of the state government. The company has sought to produce state-of-the-art natural fibre-based industrial sacks, a substitute of plastic. The company has also proposed an investment of Rs 325 crore for manufacturing value added products for the automotive and glass industry.



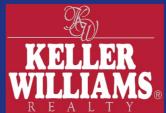
